UNINCORPORATED INFORMAL AFFILIATION OF FREELANCE PRACTITIONERS

NAME: Fowler+Sumner

AIMS:

The overall purpose of Fowler+Sumner is to pool resources as freelance practitioners, improve our overall skillset, increase opportunities to work in our medium, and to work together as participatory digital media artists.

OBJECTIVES:

- 1 To develop a joint portfolio of work.
- 2 To develop a joint philosophy of arts practice.
- 3 To develop a joint methodology for participatory arts delivery.
- 4 To maximise our potential as affiliated freelance practitioners.
- 5 To formalise an arts partnership with the aim of building an arts organisation.

POWERS:

- 1 We can set up an office.
- 2 We can hire, lease, rent or purchase premises and equipment in order to carry out our activities.
- 3 We can subcontract other freelance artists on Fowler+Sumner commissions.
- 4 We can promote our creative practice.
- 5 We can collaborate with other organisations or charities that have similar or related aims and objectives.
- 6 We can work with other groups and organisations on projects of joint interest.
- 7 We can pay expenses and the cost for setting up and running Fowler+Sumner.
- 8 We can carry out any other legal activity that supports or furthers the aims of the group.

MEMBERSHIP:

- 1 Arron Fowler & Martin Sumner are the only members of this group.
- 2 The rights of a member cannot be transferred to another person.
- 3 There are no membership fees.

How membership to Fowler+Sumner can end:

- 4 A person can end their membership by mutual consent at any time.
- 5 The affiliation will end if one member ends their membership.

GENERAL MEETINGS:

- 1 Fowler+Sumner must hold General Meetings three times each year.

MANAGEMENT COMMITTEE:

1 There is no management committee as both parties are jointly responsible for the affiliation.

CONSTITUTION:

- 1 Any changes to this constitution will need to be approved by both members.
- 2 The constitution will be changed when the informal affiliation becomes a formal partnership.

FINANCE:

- 1 The Unincorporated Informal Affiliation will not raise money directly. Funding will be raised by the individual members and funds held by them against agreed projects and activities.
- 2 All the money raised for Fowler+Sumner by the artists will be used for the objectives written in the constitution.

DISSOLUTION:

- 1 If the partners agree that it is necessary to dissolve Fowler+Sumner they will agree a 30-day grace period to conclude matters pertaining and arising.
- 2 Assets owned by the partnership will become the sole property of the donating artist.
- 3 Assets donated to the partnership will be donated to a local charitable or community with similar or related aims.
